

**APPLICATION FOR
OVER-WIDTH, OVER-HEIGHT OR OVER-LENGTH

I, the undersigned, hereby make application for a permit to move, haul or transport _____ (vehicle, load or attachment) upon, across or over highways, roads, bridges or culverts under the jurisdiction of Cowley County, the dimensions of which exceed the limits of K.S.A. 8-1902 and K.S.A. 8-1903.

It is hereby agreed that said moving operation shall be done in accordance with all the requirements of the laws of the State of Kansas and Cowley County Resolution No. 02-06, in a careful and workmanlike manner, and that I will hold Cowley County harmless from all loss and expense or liability of any kind whatsoever suffered, including costs incurred in the defense of any suit or action resulting from the issuance of this permit.

The applicant shall, at the applicant's sole expense and to the satisfaction of the County Engineer or his designee, reinstall, repair, or replace any road signs, markers, guardrails, or other fixtures that have been removed, damaged, or destroyed by the applicant's activities.

In the event the applicant fails, neglects, or refuses to properly reinstall, repair or replace any removed, damaged or destroyed roads signs, markers, guardrails, or other fixtures, the applicant shall be liable to Cowley County for all costs incurred by Cowley County to reinstall, repair, or replace such road signs, markers, guardrails, or other fixtures.

That no permit shall be issued to any person, corporation, or other entity that has an outstanding obligation to Cowley County pursuant to Resolution No. 02-08.

It is further agreed that in addition to the \$25.00 fee paid herewith I will file with the Cowley County Clerk a surety bond in the sum of \$ 2,000.00 binding to Cowley County and a Certificate of Insurance demonstrating evidence of satisfactory Commercial General Liability and Automobile Liability insurance.

It is further agreed that I will, upon the issuance of a Moving Permit on the basis of this application, give not less than forty-eight (48) hours notice of the intent to move the above described structure, and should the moving operation be delayed I will again give not less than forty-eight (48) hours advance notice of the actual moving operation.
